- □ Non-Profit Membership: \$50 open to any registered 501c3 non-profit that is NOT an Equine Rescue or Sanctuary. UHC now offers a free membership specifically for equine rescues and sanctuaries sponsored through our partnership with A Home For Every Horse, which can be accessed on our website. Non-profit members are non-voting members.
