#### Introduction

The Equine Welfare Data Collective (EWDC) collects national data on equine welfare from 501c3, or stateregistered nonprofits, and municipal organizations that function as transition centers, adoption centers, rescues, sanctuaries, shelters, direct placement programs, and other services involved in equine welfare.

The EWDC only collects this information with the intention to understand the needs of the equine rescues, sanctuaries, and other welfare programs and the unique challenges that they face.

The success of the EWDC depends upon shelters, rescues, sanctuaries, funders, and other organizations that house or otherwise support horses in transition to contribute data to the collective and to encourage all groups to do the same. Organizations such as UHC, TRH, ASPSCA, AHFEH, and GFAS will be looking for your contribution to the EWDC as part of their membership, partner, and/or funding considerations.

Your data contribution provides for more accurate study results to help you understand and communicate the scope of the issues you are tackling and better serve your community.

We use the term "equine". Equine encompasses any member of the Equidae family, including horses, ponies, donkeys, zebras, and any hybrid (mules, hinnies, zedonks, etc.) Here is what you will need to complete the survey today:

1. Your organization's EIN Number. This is used for internal record-keeping purposes as an identifier to ensure there are no duplicate data submissions. We never share your EIN, or any other identifying information you provide.

2. Current records cover January 1, 2024 - June 30, 2024. We collect data by category (e.g number of intakes via owner surrenders, agency transfer, law enforcement confiscation, etc.) so it is important to ensure you have access to your organization's complete records. We will be collecting data by category.

Your privacy is important to us. We understand your organization is sharing sensitive data with the EWDC. We *never* share any information without your explicit permission. Participation in our surveys allows us to share analyzed data as an aggregate. Your data will be grouped with all submitted data from all participating organizations with no identifying information attached.

Some grant funding agencies, certifying bodies, and municipal groups require <u>active</u> participation in the EWDC. In order for us to verify participation within the program, you must grant us permission to share your EWDC participation with these organizations, such as ASPCA, TAA, AHFEH, SAC, etc.

We previously provided members with EWDC certificate letters that you could share as proof of participation. If we are permitted to share your participation level, you no longer need a certificate letter, though we are happy to supply one upon request.
